The parties hitherto agree as follows.

1. The MOU is done on 1/3/2021 for period of One year starting from 1/3/2021 to 28/2/2022 and will end on automatically.
2. Party one declares that they have MUHS and MCI recognized Post Graduate students of MS Course for Ophthalmology and has approved capacity of 4 student per year and MUHS & MCI recognized UG Students
3. Party one intends to provide exposure in refractive surgeries in ophthalmology like Laser to PG MS Students & UG Students.
4. Party Two has well equipped Refractive surgery Centre where PG MS Students and UG Students can get proper exposure to and understanding of refractive surgeries techniques (LASIK). Party Two has agree to provide exposure to refractive surgery as mentioned in clause 1
5. Party two would provide the exposure in the form of observership only without any hands on training.
6. Party One intends to send PG and UG students to Party Two for observing Lasik procedure.
7. Party Two has agreed that they would provide this exposure.

This agreement will take effect from the date of its signing and shall be valid for the period of one year that is mutually decided and formalized. This mutual return agreement between the parties may be extended by mutual agreement.

Either party may terminate the agreement at any time during the terms by the provision of 3 months return notice to the either parties.
