1. The MoU is done on February 04, 2020 for a period of Five Years (5 Years) starting from February 04, 2020 and will end on February 03, 2025 automatically.




2. **Party One** declares that they have MUHS and MCI recognized UG - MBBS Course and MD Psychiatry.
