I am directed to state that the Board of Governors considered the Council Assessor's Report(s) (12.06.2019) on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery) qualification for 5 seats in respect of students being trained at Dr. Vasantarao Pawar Medical College & Research Centre, Nasik granted by Maharashtra University of Health Sciences, Nashik and Committee decided as under:-

"The Board of Governors considered the Council Assessor's Report (12.06.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MS(General Surgery) qualification for 5 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Dr. Vasantarao Pawar Medical College & Research Centre, Nasik be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.
