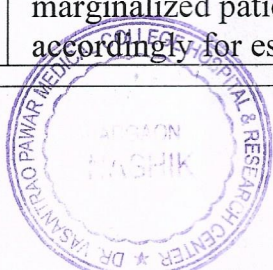

8	The need for establishing 'Innovation and Incubation Centre (IIC)' for conducting different projects, research and training programs for undergraduate & postgraduate students was discussed. CRL can be upgraded as Incubation Centre which can be finalized after discussion with CRL in-charge and HOI.
9	Hon'ble Education Officer, Dr. N.S. Patil and Hon'ble Dean, Dr. Mrunal Patil madam suggested for establishment of Tele-medicine centre at institute for catering health services in rural and tribal areas. Collaboration in this regard will be undertaken with Government or NGOs.
10	Hon'ble Dean, Dr. Mrunal Patil madam also suggested for applying NIRF (National Institutional Ranking Framework) which is a methodology adopted by the Ministry of Education, Government of India to rank higher educational institutions based on various parameters related to faculty, students, research and teaching-learning activities. Dr. Sankalecha madam and other members agreed for the same as it will help institute to improve quality and project itself at national level.
