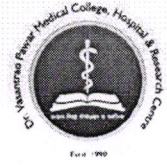
Key Meeting Outcomes:

Point no	Description
1	IQAC Director welcomed all members of IQAC cell.
2	Dr. Sankalecha madam, IQAC Director briefed the agenda of meeting to members.
3	She introduced objectives, strategies and functions of IQAC cell followed by the activities undertaken for the year as per the Action Plan of 2022-23. She also discussed the strategic plan for 2019-24, quality policy and vision-mission of the institute and invited suggestions, if any.
4	Dean and IQAC Chairman, Dr. Vidya Paranjape Madam suggested changes in core values of the vision-mission of the institute. The suggestions were accepted after discussion.
5	Dr. Sankalecha, IQAC Director told the members about various initiatives undertaken by the institute namely, Tele-medicine unit, Organ transplant centre, NIRF ranking, academic and administrative audits, guest lectures for college going students, health awareness maha-rallies for the community, workshops for teachers, UG and PG students, feedback from stakeholders, increase in PG intake etc.
6	Dr. Sankalecha madam has also informed all members about the renewal process of ISO 21001 certification of the institute.
7	Dr. Rakesh Patil sir sensitized all members about salient features of National Education Policy 2020. Currently, medical education is regulated by NMC

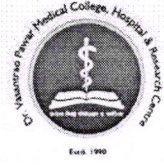

	(National Medical Commission) and hence there is limited scope for the implementation of NEP 2020 in medical field but the necessary preparation like faculty sensitization, upscaling of teaching-learning and research activities are undertaken by the institute within the framework given by regulatory authorities namely, NMC & MUHS (Maharashtra University of Health Sciences) to support NEP 2020 strategies.
8	The need for establishing 'Innovation & Incubation Centre (IIC)' for Innovations, Patenting, copyright, start-ups etc., <u>Smart classrooms for T-L activities</u> and 'Research Policy' at institute level for conducting different research projects and training programs for undergraduate & postgraduate students was discussed by all members. Dr. Prasad Sonawane Sir assured all support from management for the same.
9	IQAC Director also suggested that capacity building of faculty for starting value-added courses (online), add-on courses including Ph.D. programs, life skills and soft skills will be undertaken in the year 2023-24. It was also suggested to establish faculty evaluation system at institute level, to further increase social and outreach activities in Nashik district and to promote up gradation of knowledge and up skilling of teaching faculty for further improving the quality of teaching and reduce gaps in teaching-learning as per the recent guidelines given by NMC about 'Professional responsibilities of Medical Teachers'.
10	Then, the Dean, Dr. Vidya Paranjape madam, told all IQAC members to provide their inputs for the quality enhancement and sustenance.
11	Dr. Prasad Sonawane sir, MVP Management representative has asked the priority tasks to be undertaken and told that he will provide necessary support from management in these activities. He also discussed mobilization of CSR funding from reputed organizations and philanthropists.
12	Dr. Raj Nagarkar sir, suggested focusing on institution based research projects involving UG/PG students and opt for funding from reputed agencies like ICMR, TATA etc. for the same. He also stressed the importance of self-sufficient research funding model by involving pharmaceutical industry sponsored research at institute level.
13	Dr. Raviraj Khairnar sir appreciated the efforts taken by the institute for students' overall development and provision of healthcare services to the needy & marginalized population.
14	Dr. Santosh Shinde sir suggested having solar system installation on the parking shed for promoting green campus initiative. Dr. Prasad Sonawane sir told all members that MVP Samaj trust has sanctioned installation of Solar System in all MVP institutes and soon it will be implemented in this institute too.
