(iv) Other:

- a. The College shall submit Affidavit in the prescribed format as per Academic Council's. Resolution No. 229/2013 (format attached).
- b. For those UG / PG qualifications that are not yet recognized by the Central Govt., it shall be mandatory for the College to apply to the Central Council / Commission through Central Govt. and ensure that "Permitted" / "Not Recognized" qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year and no student shall be admitted in such courses.
- (v) Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 03 (three) months, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.

You are requested to comply with the above mentioned deficiencies within 03 months of date of this letter without fail and submit compliance report.

Important Note:

- 1) This conditional Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of National Medical Commission and / or Government of India. Further, if the permission is declined by the said authorities, this conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1st Year of the course until receipt of permission of the National Medical Commission and / or Government of India.
- 2) The admission shall be done through the Competent Authorities only.
- 3) If, National Medical Commission (NMC) has granted conditional renewal to the College for the Academic year 2025-26 subject to compliance of discrepancies within 04 month or specified time period as mentioned in NMC letter and if subsequently action of revocation of conditional renewal or reduction of seats taken by National Medical Commission, accordingly the decision of National Medical commission shall be final and binding in this matter. Therefore, this conditional Continuation / Extension of Affiliation issued by University shall be subject to the decision of National Medical Commission and compliance of deficiencies informed by the University.
